LATEST UPDATES AND PROGRESS

The USM team, City of Virginia Beach staff, and other key stakeholders have kicked off the New Year meeting multiple times each week in an effort to complete a comprehensive agreement for the Arena Project. The goal is to have documents completed in time for an anticipated vote by City Council in the Spring of 2015.

Several workgroups have been established to develop a framework for policies and procedures in the areas of parking and traffic management, event day services, and booking and coordination with city planners and services, including the CVB and Virginia Beach Convention Center. Additional workgroups are focused on all aspects of design and construction and creating the actual agreement.

All participants are motivated to identify potential issues and concerns, and actively seek solutions that will make the wisest use of City and developer resources and best manage potential impact to neighboring communities and businesses. Everyone is working towards the goal of opening a successful arena that coordinates well with City and public events, creates opportunities for local residents to enjoy, and new reasons for tourists to visit the Hampton Roads area year round.

Since 1995, Jon has been responsible for leading the design and planning of collegiate and professional stadium and arena work with AECOM. He's been involved in designing numerous arenas, including the AT&T Center, Barclays Center, FedEx Forum, Sprint Center, Time Warner Cable Arena, John Paul Jones Arena, and Verizon Center, to name a few.

Jon led the design of the CenturyLink Field Stadium, home to the Seattle Seahawks who are headed to Super Bowl XLIX! The stadium has a seat capacity of 72,000 and roof coverage for 70% of the seats; the roof was curved to reflect noise toward the field, making it one of the loudest outdoor sports stadiums and creating a tremendous fan experience.

Jon and his team at AECOM are the lead architects for the new NBA Sacramento Kings arena currently under construction. Set to open Fall 2016.
